

105.7 WROR UNIVERSAL ORLANDO RESORT

OFFICIAL CONTEST RULES

These rules apply to the 105.7 WROR Universal Orlando Resort Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WROR- FM (“Station”). In addition, the General Contest Rules posted at wror.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.

1.) HOW TO ENTER:

a. The Contest will begin on Monday, February 23, 2026, and end on Sunday, March 15, 2026.

b. To enter the Contest, entrant may enter as follows:

- I. To enter via the Keyword method of entry, listen to the Station each weekday beginning on Thursday, March 5, 2026, and ending on Friday, March 13, 2026, between the hours of 8:00am Eastern Time (“ET”) and 5:00pm ET for the announcement of the unique Code Word (“Keyword”). Each day’s announcement will have a unique Keyword. Up to five (5) Keywords will be announced each day. Once an entrant hears the Keyword, entrant may enter via the following method:

Visit www.wror.com and follow the links and instructions to enter the Contest and complete and submit the online entry form including the daily Keyword. Online entrants are subject to all notices posted online including but not limited to the Station’s Privacy Policy. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.

Limit one (1) entry per eligible person per Keyword regardless of if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entrants are not permitted to use multiple email addresses. Each entry window shall close at the start of the twentieth (20th) minute after the Keyword is announced. Any online entries received after the entry deadline or any online entries with the incorrect daily Keyword will be disqualified.

- II. For an additional chance to win, entrant may enter online as follows: Visit www.wror.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning at 6:00am ET on Monday, February 23, 2026 and ending at 11:59pm ET on Sunday, March 15, 2026 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station’s Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be

acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.

- c. There will be up to a total of eight (8) winners (seven (7) from the Keyword method of entry and one (1) from the online-only method of entry) selected in the Contest.

2.) ELIGIBILITY RESTRICTIONS

- a) This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Massachusetts, New Hampshire or Rhode Island, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3.) PRIZES

- a) Up to eight (8) Prizes (each a “Prize”) will be awarded. Each Prize Winner (“Winner”) will receive a five (5) day, four (4) night trip for Winner and up to one (1) Guest (“Guest”) to Universal Orlando Resort in Orlando, Florida.

Trip will include round trip economy class air transportation for each Winner and Guest from a major commercial airport near Winner’s home (*provided by Spirit Airlines*) to Orlando, Florida*; four (4) nights’ standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Universal Terra Luna Resort or at another Universal Orlando Resort hotel (as determined by Universal Orlando in its sole discretion); non-exclusive ground transportation to and from airport and hotel in Orlando, Florida*; and Universal Orlando 4-Day Park-to-Park Tickets for admission to Universal Studios Florida, Universal Islands of Adventure and Universal Epic Universe theme parks and Universal Volcano Bay water theme park for Winner and Guest.

The Approximate Retail Value (“ARV”) of the Prize is Two Thousand Nine Hundred Twenty three and 08/100 Dollars (\$2,923.08).

Trips must occur from March 15, 2026 – March 15, 2027 or Prize will be forfeited. Travel dates and arrangements are subject to air travel, holiday, blockout dates, and other prize and travel restrictions. Travel dates are subject to Universal Orlando and Sponsor approval. Reservations are subject to availability. Trip must be booked at least sixty (60) days prior to intended departure date. If Winner elects to partake in any or all portions of the Prize with fewer than the allotted number of Guests or no Guests, the Prize will be awarded to Winner and each participating Guest and any remainder of the Prize will be forfeited and shall not be subject to further or alternative compensation. All elements of the Prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption. If Winner is between the ages of eighteen (18) and twenty-one (21), Winner must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the hotel. Unless child or ward of Winner or one of the allotted Guests, each Guest must be eighteen (18) years of age or older as of the date of departure and must travel on

the same itinerary and at the same time as the Winner. ARV of Prize may vary depending upon the points of departure, ground transportation, and/or airline fare fluctuations; any difference between stated ARV and final ARV of Prize will not be awarded. Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, meals, unspecified ground transportation, phone calls, baggage, gratuities, incidentals, souvenirs, gasoline, etc.) are included in the Prize and all such expenses are the sole responsibility of Winner. Winner is responsible for any air travel taxes and/or expenses, including applicable departure taxes or fees, inspection charges, baggage fees, and security charges. Winner and Guests are responsible for obtaining, at their own expense, any necessary travel documentation (i.e. valid photo identification, visas, passports, etc.) prior to travel. Once issued, tickets are nontransferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. Travel arrangements must be made through Universal Orlando.

In connection with any visit to Universal Orlando Resort, please be advised that Universal's policies, CDC guidelines, and the recommendations of health officials must be followed. In addition, guests should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before visiting any Universal destination. Please note that any public location where people are present provides an inherent risk of exposure to COVID-19, and Universal cannot guarantee that any person will not be exposed during a visit.

All parts of the prize are subject to availability and blackout dates, and subject to change without written notice or warning. Should any circumstances beyond the reasonable control of a party, whether or not existing, known, foreseen or foreseeable at the time this Promotion occurs, render the redemption or fulfillment of some or all of the prize delayed, hindered, adversely affected, impracticable, or impossible, Universal Orlando Resort in its sole and absolute discretion, reserves the right to evaluate and make modifications to the redemption and fulfillment processes and timelines for the prize, which may include but is not limited to providing additional time for redemption and/ or fulfillment, or offering experiences and items of an equivalent or greater value. Universal Volcano Bay water theme park will be closed for a seasonal refurbishment from October 26, 2026, to on or before March 24, 2027. If winner chooses to travel at a time that coincides with this extended closure, they will forfeit admission to Universal Volcano Bay water theme park without alternative or further compensation.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental

expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, winner and guest(s) should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip. **Winner will be issued a 1099 for 2026, regardless of when the winner redeemed the Prize trip.**

- b) Prizes or prize certificates must be claimed at the office of the Station located at 1075 Main St., Suite 300, Waltham, MA 02451, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the Winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4.) SELECTION OF WINNERS

- a) Up to seven (7) Winners will be selected via the Keyword method of entry as follows:

Up to one (1) Winner will be selected each weekday beginning on Thursday, March 5, 2026, and ending on Friday, March 13, 2026 at approximately 5:30pm ET in a Station-conducted random drawing from all eligible entries received for that daily Keyword. Potential Winner will be notified by phone promptly following the random drawing.

non-selected entries will not roll over into subsequent Keyword random drawings, if any.

- b) Up to one (1) additional Winner will be selected at approximately 12:00pm ET on Monday, March 16, 2026, in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Winner will be notified by phone and/or email promptly following the random drawing.
- c) Odds of winning a Prize via the Keyword method of entry depend on the number of eligible Keyword entries received for each daily random drawing. Odds of winning a Prize via the

online-only method of entry depend on the number of eligible online entries received during the Online Entry Period.

- d) Keyword method of entry entrants must listen to the Station but do not need to be present to enter or win a Prize. Online-only method of entry entrants need not listen to the Station or be present to win a Prize.
- e) Winners must confirm acceptance of Prize within five (5) days of winning, or risk disqualification and selection of an alternate Winner (time permitting) in a random drawing of all remaining eligible online entries receiving during the Online Entry Period (for keyword and online-only method of entry).

Any disputes, claims, and causes of action against Universal Orlando arising out of or relating to any person's use of or participation in any portion of the Prize provided by Universal Orlando shall be resolved by applying the laws of Florida, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in state or federal courts within Orange County, Florida.
